Order No. 20 of 1939.

ORDER

MADE UNDER THE COURTS ORDINANCE.

By virtue of the powers conferred on me by sub-section (1) of section 19 of the Courts Ordinance, I HEREBY ()RDER as follows:—

- 1. This Order may be cited as the Provinces and Districts Short title. (Boundaries) (Amendment) Order, 1939.
- 2. Section 1 (2) of the Provinces and Districts (Boundaries) Order made under section 19 (1) of the Courts Ordinance and appearing on pages 2-21 of Volume III of the Revised Laws is hereby amended:—

 Amendment of definition of Eastern Province in Order appearing

(a) by deleting the word "Akwapim" and substituting therefor the words "Akwapim-New Juaben".

(b) by deleting the words "New Juahen".

3. The Schedule to the said Order is hereby amended as Amendment of the Schedule

- (a) By deleting that part thereof defining the boundaries of the Winneba District in the Central Province, and substituting therefor the following:—

 Schedule to Order appearing on pages 2-21 of
- (4) THE WINNEBA DISTRICT, THE BOUNDARY WHEREOF:
 - 1. Starting from the sea at a Survey Beacon G.C.S. 532 Laws. half a mile west of Legu it runs in a straight line in a north-westerly direction to the point where the road between Gomoa Brofo and Mando crosses the River Nakwa.
 - Thence it follows the thalweg of the River Nakwa upstream to a point one mile south of Ochiso.
 - Thence it runs in a straight line in a north-easterly direction to a point halfway between Nkum and Odoben on the road between these villages.

Amendment of the Schedule to Order appearing on pages 2-21 of Vol. III Revised Laws.

- 4. Thence it runs in a straight line in a north-easterly direction to a point called "Dumpara" about 4½ miles south of Akroso on the road from Akroso to Nsaba.
- 5. Thence it runs in a straight line in a northerly direction to a point called Abuoso where the River Akora crosses the bush track from Asamankese to Akroso about 4½ miles from Akroso.
- 6. Thence it runs in an easterly direction to the point where the River Ayensu crosses the road from Adaiso to Asamankese.
- 7. Thence it follows the road from Asamankese to Adaiso in a south-easterly direction until it meets the Town boundary of Adaiso, but so as to exclude from the district the road itself and all villages thereon.
- 8. Thence it follows the Town boundary of Adaiso in a south-westerly, south-easterly and north-easterly direction until it meets the bush track from Adaiso to Accra.
- Thence it follows the bush track from Adaiso to Accra in a south-easterly direction until it reaches the River Densu.
- 10. Thence it runs in a south-westerly direction to a point where the boundary between the Accra and Bereku chiefs crosses the road from Amanfro to Odupon about 1,100 yards east of Odupon.
- 11. Thence it runs in a straight line in a south-easterly direction to a point on the coastline halfway between Nyanyanu and Kokrobete.
- 12. Thence it follows the coastline to the starting point of the district at Point 1.
- (b) By deleting that part thereof defining the boundaries of the Accra District of the Eastern Province, and substituting therefor the following:—
 - (1) Accra District, the Boundary whereof:
- Starting from the sea at a point halfway between Nyanyanu and Kokrobete runs in a north-westerly direction to a point where the boundary between the Accra and Bereku chiefs crosses the bush track from Amanfro to Odupon about 1,100 yards east of Odupon.
- 2. Thence it runs in a north-easterly direction until it reaches the River Densu at the point where it is crossed by the bush track from Adaiso to Accra near the village of Otuaplem.
- 3. Thence it follows the bush track from Adaiso to Accra in a north-westerly direction until it reaches the town boundary of Adaiso.

- 4. Thence it follows the town boundary of Adaiso in a north-easterly and north-westerly direction until it meets the motor road from Adaiso to Nsawam.
- 5. Thence it follows the road from Adaiso to Nsawam in an easterly direction until it meets the Nsawam Town Boundary and so as to include the road itself and all the villages thereon.
- 6. Thence it follows the town boundary of Nsawam in a southerly, easterly and northerly direction until it crosses the road from Nsawam to Aburi.
- 7. Thence it follows the road from Nsawam to Aburi as far as the stream Ahinfina.
- 8. Thence it runs in a straight line in a south-easterly direction to a point where the tribal boundary between Aburi and Accra crosses the bush track 200 yards south of the village of Mpehuasem.
- 9. Thence it runs in a straight line in a south-easterly direction to where the tribal boundary between Aburi and Accra crosses the bush track from Odoben to Accra between the villages of Nsaki and Bodomase.
- 10. Thence it runs in a straight line in an easterly direction to where the tribal boundary between Aburi and Accra crosses the bush track from Obodam to Abokobi between the villages of Berekuso and Sesemi.
- 11. Thence it runs in a straight line in a north-easterly direction to the point where the stream Okuampa crosses the road from Aiyimensa to Aburi about half a mile north of Aiyimensa.
- 12. Thence it runs in a straight line in a north-easterly direction to a point halfway between the villages of Adamrobe and Saduasi.
- 13. Thence it runs in the same direction until it reaches a point half a mile from the main Accra-Somanya road (101E) at mile 22½ from Accra.
- 14. Thence it runs distant half a mile from and parallel to and on the north-west side of that road until it reaches the Dodowa Town Boundary.
- 15. Thence it follows the said Town Boundary successively in a northerly and an easterly direction so as to include the town of Dodowa until it reaches a point half a mile from the main Accra-Somanya Road.
- 16. Thence it runs distant half a mile from and parallel to and on the north-west side of that road until it reaches a point half a mile approximately north-west of a pillar marked A-VR 2 on the road from Akwale to Agomeda.
- 17. Thence it runs to the pillar aforesaid.

- 18. Thence it runs in a straight line in an easterly direction until it meets a Trigonometrical Survey beacon marked 2015 on Muate Hill.
- 19. Thence it runs in a straight line in a south-easterly direction to a point midway between the villages of Some Wayo and Some.
- 20. Thence it runs in a straight line in an easterly direction to a point approximately 2 miles north-east of the village of Dawa and 1 mile north-north-east of Survey Beacon No. C.F.P. 164.
- 21. Thence it runs in a straight line in a southerly direction to but excluding the town of Wekumagbe.
- 22. Thence it follows the sea to the starting point of the district at Point 1.
- (c) By deleting that part thereof defining the boundaries of the Akwapim District of the Eastern Province, and substituting therefor the following:—
- (3) AKWAPIM-NEW JUABEN DISTRICT, THE BOUNDARY WHEREOF:
 - 1. Starting from where the southern boundary of the town of Nsawam crosses the River Densu it follows the thalweg of the River Densu upstream to its junction with the stream Afene.
 - 2. Thence it follows the thalweg of the stream Afene to the boundary pillar about 2,000 vards upstream.
 - 3. Thence in a straight line in a north-easterly direction to a point where the main Koforidua Kukurantumi road crosses the Suhien Stream.
 - 4. Thence it follows the thalweg of the Suhien stream to the Suhien Falls (locally known as Aboadaka) and marked by Gold Coast Survey Pillar E.P.20.
 - 5. Thence it runs in a straight line in a south-easterly direction for an approximate distance of 2,923 yards to a point where a tree marked J.S. 1921 now stands.
 - 6. Thence it runs in a straight line in a south-easterly direction for an approximate distance of 3,650 yards to a pillar marked G.H.P.
 - 7. Thence it runs in a straight line in a south-easterly direction to a rock approximately 700 yards west of the village of Ntronang.
 - 8. Thence it runs in a straight line in an easterly direction so as to include the village of Ntronang in the district to a point where the River Nyense crosses the road from Koforidua to Okrakwajo close to and west of Okrakwajo.
 - 9. Thence it runs in a straight line to a point approximately 1 mile due north of the last named road.

- Thence it runs parallel to and one mile due north of bush track from Okrakwajo to Somanya until it reaches a point due north of Asunasi Village.
- Thence it runs due north to Asunasi, that village to be excluded.
- 12. Thence it runs in a straight line in a south-easterly direction to where the Krobo Western Boundary cuts the track from Aperede to Trom at a point about 1½ miles due west of Trom.
- 13. Thence it runs in a straight line in a south-westerly direction to the point where the stream Aplachi crosses the same road.
- ¥ 14. Thence it follows the thalweg of the stream Aplachi to
 where it crosses the road from Trom to Asesieso at a
 boundary pillar marked A. -/V.R./1.
 - 15. Thence it runs in a straight line in a south-easterly direction following a line from pillar A-V.R. 1, on the road from Trom to Asesieso, to pillar A-V.R. 2 on the road from Akwale to Agomeda until it reaches a point ½ mile west of the last named road.
 - 16. Thence it runs distant ½ mile from and parallel to and on the north-western side of the Accra-Somanya Road, until it meets the town boundary of Dodowa.
 - 17. Thence it follows the said town boundary in a westerly and southerly direction until it reaches a point ½ mile west from the Accra-Somanya Road.
 - 18. Thence it runs distant \(\frac{1}{2}\) mile from and parallel to the Accra-Somanya Road until it reaches a point \(\frac{1}{2}\) mile due west of a point on the above-mentioned road \(22\)\(\frac{1}{2}\) miles from Accra.
 - 19. Thence it runs in a straight line in a south-westerly direction to a point halfway between the villages of Adamrobe and Saduasi.
 - 20. Thence it runs in a straight line in a south-westerly direction to a point where the stream Okuampa crosses the road from Aiyimensa to Aburi about ½ mile north of Aiyimensa.
 - 21. Thence in a straight line in a south-westerly direction to where the tribal boundary between Aburi and Accra crosses the track from Obodan to Abokobi between the villages of Berekuso and Sesemi.
 - 22. Thence it runs in a straight line in a westerly direction to where the tribal boundary between Aburi and Accra crosses the track from Obodan to Accra between the villages of Nsaki and Bodomase,

- 23. Thence it runs in a straight line in a north-westerly direction to where the tribal boundary between Aburi and Accra crosses the bush track 200 yards south of the village of Mpehuasem.
- 24. Thence it runs in a straight line in a north-westerly direction to where the stream Ahinfina crosses the road from Aburi to Nsawam.
- 25. Thence it follows the road from Aburi to Nsawam in a westerly direction until it meets the town boundary of Nsawam.

Thence it follows the town boundary of Nsawam in a southerly and westerly direction to the starting point of the district at Point 1.

- (d) By deleting that part thereof defining the boundaries of the Birim District of the Eastern Province, and substituting therefor the following:—
- (4) THE BIRIM DISTRICT, THE BOUNDARY WHEREOF:
- Starting from the confluence of the River Volta and the River Obosum it follows the thalweg of the Obosum River to its junction with the Babadua stream.
- 2. Thence it runs in a straight line in a south-westerly direction to the junction of the Afram and Onyim River.
- 3. Thence it follows the thalweg of the Onyim River upstream to the junction of the Onyim and Supon Rivers.
- 4. Thence in a straight line in a south-easterly direction to the junction of the Fomang and Sutiri Rivers.
- 5. Thence it follows the thalweg of the Fomang River in a southerly direction to a point \(\frac{1}{4} \) mile north of the road from Fomangso to Fomangkesi.
- 6. Thence it runs parallel on the northern side of and ¼ mile distant from the road from Fomangso through Mamfe and Ahireso to Kwahu Praso until it reaches the left bank of the River Pra.
- 7. Thence it follows downstream the left bank of the River Pra to the point where the Kwahu Kotoku boundary joins the River Pra.
- 8. Thence it follows the Kwahu Kotoku boundary in an easterly, south-easterly and southerly direction to the summit of Kade Bepo.
- 9. Thence it runs in a south-westerly direction to the top of the Hiuwungu Bepo and thence to the bottom of the mountain to a point on the bush track between Kadewaso and Pankese where there is an Onyema tree.
- 10. Thence in a westerly direction to the Senemang Stream at the point where there is a Dahuma tree.

- 11. Thence it follows the Senemang Stream in a westerly direction until it meets the New Akoasi Jimaa bush track.
- 12. Thence it runs in a southerly direction along the right side of the said track coming from New Akoasi until it meets the Mamang Stream.
- 13. Thence it follows the right bank of the Mamang Stream in a south-westerly direction to the point where a straight line drawn between the point where the Asuom Ntronang track crosses the Akoyenso or Ohemia Su and the point where the Asuom Nyafomang track crosses the Obohima Stream would intersect the right bank of the Mamang Stream.
- 14. Thence it runs in a north-westerly direction along that line to the point where the Asuom Nyafomang track crosses the Obohima Stream.
- 15. Thence it runs in a south-westerly direction along the right bank of the Obohima Stream to its junction with the Mamang Stream.
- 16. Thence it follows the right bank of the Mamang Stream in a westerly direction to a point \(\frac{1}{2} \) mile east of the village of Mamangso where there are three stones.
- 17. Thence in a straight line to the confluence of the Kawura and Abusu Streams where there is a Survey Beacon No. 29.
- 18. Thence in a straight line to the source of the Dangumeso (Dahomesu) Stream where there is a Survey Beacon No. 28.
- Thence in a straight line to the crossing of the Ajuafo-Aberem track and the Denyami Stream where there is a Survey Beacon No. 27.
- 20. Thence in a straight line to the point where the Abene (Ablasu) Stream crosses the Ajuafo-Aberem track where there is a Survey Beacon No. 26.
- 21. Thence it follows the thalweg of the Abene (Ablasu) Stream in an upstream direction to a point on the Abene (Ablasu) Stream north of the Chia-Kwae Hammock Road where there is a Survey Beacon No. 25.
- 22. Thence in a straight line to a point on the Chia-Kwae Hammock Road between it crossings of Acheresu and Abene (Ablasu) Streams, where there is a Survey Beacon No. 24.
- 23. Thence in a straight line to a point on the Acheresu Stream south of the Chia-Kwae Hammock Road where there is a Survey Beacon No. 23.

- 24. Thence in a straight line to a point on the Otumi-Ajuafo path lying between two camps known as Dahaura and Adadiasi where there is a cement pillar No. 22.
- 25. Thence it follows a straight line in a south-easterly direction to a point on the Otumi-Akokoaso path between the Siaa and Aiyaola Streams where there is a cement pillar No. 21.
- 26. Thence it follows a straight line in a south-westerly direction to a point on the Okumani-Akokoaso path between a camp known as Katawenyitu and the Efiefi Stream where there is cement pillar No. 20.
- 27. Thence it follows a straight line in a south-westerly direction to the junction of the Subin Stream with the Nsuansa Stream where there is a cement pillar No. 19.
- 28. Thence it follows the thalweg of the Subin Stream in a downstream direction to a point on the Subin Stream where there is a cement pillar No. 18.
- 29. Thence it follows in a straight line in a south-westerly direction to a cement pillar No. 17.
- 30. Thence it follows in a straight line in a southerly direction to a hunter's camp known as Isasi where there is a cement pillar No. 16.
- 31. Thence it follows in a straight line in a south-easterly direction to a point on the Subin Stream where there is a cement pillar No. 15.
- 32. Thence it follows the thalweg of the Subin River in a downstream direction to a point on the stream where there is a cement pillar No. 14.
- 33. Thence it follows a straight line in a south-westerly direction to a point on the Ataw Stream where there is a cement pillar No. 13.
- 34. Thence it follows a straight line in a south-westerly direction to a point known as Warakese where there is a cement pillar No. 12.
- 35. Thence it follows a straight line to a point on the Atochesu Stream near a hunter's camp known as Esemwhere there is a cement pillar No. 11.
- 36. Thence it follows a straight line in a westerly direction to the source of the Akurubunsu Stream where there is a cement pillar No. 10.
- 37. Thence it follows the thalweg of the Akurubunsu Stream in a downstream direction to a point where the Wanchi-Nkwanta path crosses the Akurubunsu Stream marked by a cement pillar No. 9.

- 38. Thence along the Wanchi-Nkwanta path to a point where this path is cut by the Botikuma Stream marked by a cement pillar No. 8.
- 39. Thence along the thalweg of the Botikuma Stream in a downstream direction to its mouth.
- 40. Thence to a point on the centre line of the Birim River opposite the mouth of the Botikuma Stream.
- 41. Thence along the centre line of the Birim River to a point opposite the mouth of the Adim Stream.
- 42. Thence to the confluence of the Birim River with the Adim Stream.
- 43. Thence along the thalweg of the Adim Stream to a point where the Arena (Awena) Stream flows into it.
- 44. Thence along the thalweg of the Arena Stream to a point on this stream where it is cut by a track leading from Asene to a point shown on Survey Sheet Nsaba N.W. No. 57 and indicated as "Sassankokwaso" which intersection of the said stream and track is marked by a cement pillar No. 7.
- 45. Thence along the track leading from Asene to a point marked by a cement pillar No. 6.
- 46. Thence along the northern boundary of the Asenase (Yaw Donkor and Oti) claim as shown edged brown on a registered Survey Map reference number X259, being a plan showing rival boundaries in the suit John Kodwi Boadi versus Yaw Donkor and Oti, to a point on the north-eastern corner of the above-mentioned claim marked by a cement pillar No. 5.
- 47. Thence in a straight line to the source of the Asokore Stream where there is a large Onyina tree marked by a cement pillar No. 4.
- 48. Thence along the thalweg of the Asokore Stream to where it is joined by the Aboabo Stream.
- 49. Thence along the thalweg of the Aboabo Stream to where this stream is joined by the Atiankumbra (Atiankama) Stream.
- 50. Thence along the thalweg of the Atiankumbra (Atiankama) Stream in an upstream direction to a point where this line is intersected by a line between two concrete pillars marked G.C.S.E.P. 624 and G.C.S.E.P. 633.
- 51. Thence along a cut line in a north-easterly direction and passing through Gold Coast Survey Pillars marked G.C.S.E.P. 633, G.C.S.E.P. 623, G.C.S.E.P. 632, G.C.S.E.P. 631, G.C.S.E.P. 622, G.C.S.E.P. 627, G.C.S.E.P. 626, G.C.S.E.P. 625, G.C.S.E.P. 619, G.C.S.E.P. 621, G.C.S.E.P. 620, and G.C.S.E.P. 618

- to a point where the continuation of the straight line between pillars G.C.S.E.P. 620 and G.C.S.E.P. 618 intersects the thalweg of the Supong River.
- 52. Thence along the thalweg of the Supong River and in an upstream direction to where this river is intersected by the main Manso-Osenasi Road.
- 53. Thence it runs in a straight line in a south-easterly direction to the point called "Abuoso" where the River Akora crosses the road from Asamankese to Akroso about 4¹/₄ miles from Akroso.
- 54. Thence it runs in an easterly direction to the point where the River Ayensu crosses the road from Adaiso to Asamankese.
- 55. Thence it follows the road from Asamankese to Accra in a south-easterly direction until it meets the town boundary of Adaiso to include in the district the road itself and all villages thereon.
- 56. Thence it follows the town boundary of Adaiso in a south-westerly, south-easterly, north-easterly and north-westerly direction until it meets the motor road from Adaiso to Nsawam.
- 57. Thence it follows the motor road from Adaiso to Nsawam until it meets the town boundary of Nsawam but so as to exclude from the district the road itself and all the villages thereon.
- 58. Thence it follows the town boundary of Nsawam in a southerly and easterly direction until it meets the River Densu.
- 59. Thence it follows the thalweg of the River Densu to its junction with the Stream Afene.
- 60. Thence it follows the thalweg of the Stream Afene to the boundary pillar about 2,000 yards upstream.
- 61. Thence in a straight line in a north-easterly direction to a point where the main Koforidua-Kukurantumi Road crosses the Suhien Stream.
- 62. Thence it follows the thalweg of the Suhien Stream to the Suhien Falls (locally known as Aboadaka) and marked by Gold Coast Survey Pillar E.P. 20.
- 63. Thence it runs in a straight line in a north-easterly direction to the point where the stream Aseka crosses the road close to and east of Asekesua.
- 64. Thence it runs in a northerly direction in a straight line to the point nearest to Begoro where the River Akrusu crosses the road from Begoro to Pese.
- 65. Thence it follows the thalweg of the River Akrusu to its junction with the River Afram.

- 66. Thence it follows the thalweg of the River Afram to its junction with the River Pawnpawn.
- 67. Thence it runs in a northerly direction parallel to the River Volta until it reaches the River Ada.
- 68. Thence it follows the thalweg of the River Ada to its junction with the River Volta.
- 69. Thence it follows the right bank of the River Volta to a point due west of the junction of the Volta and Dayi Rivers.
- 70. Thence it crosses the River Volta in a due easterly direction to the junction of that river on the Dayi River.
- 71. Thence it follows the left bank of the River Volta to a point due east of its junction with the Obosum River.
- 72. Thence it crosses the Volta River to the starting point of the district at Point 1.
 - (e) By deleting that part thereof defining the boundaries of New Juaben District;
 - (f) By deleting that part thereof defining the boundaries of the Volta River District of the Eastern Province, and substituting therefor the following:—
- (6) THE VOLTA RIVER DISTRICT, THE BOUNDARY WHEREOF:
 - 1. Starting at the source of the River Suhien at the northeast corner of the New Juaben Settlement runs in a straight line in a north-easterly direction to the point where the stream Aseka crosses the road close to and east of Asekesua.
 - 2. Thence it runs in a northerly direction in a straight line to the point nearest to Begoro where the River Akrusu crosses the road from Begoro to Pese.
 - 3. Thence it follows the thalweg of the River Akrusu to its junction with the River Afram.
 - 4. Thence it follows the thalweg of the River Afram to its junction with the River Pawnpawn.
 - 5. Thence it runs in a northerly direction parallel to the River Volta until it reaches the River Ada.
 - 6. Thence it follows the thalweg of the River Ada to its junction with the River Volta.
 - 7. Thence it follows the right bank of the River Volta to a point due west of the junction of the Volta and Dayi Rivers.
 - 8. Thence it crosses the River Volta and follows the old Anglo-German Boundary in an easterly direction to where it meets the Tsawe River.
 - 9. Thence it follows the Tsawe River downstream to the old German Boundary Pillar No. 1 which is situated on the right bank of the Tsawe (Alabo) River approximately 1 mile due east of the town of Frankadua.

New Juden District

- 10. Thence it follows the old Anglo-German Boundary due east from Pillar No. 1 to Pillar No. 7.
- 11. Thence it runs in a straight line due south to the source of the River Kolo.
- 12. Thence it follows the right bank of the River Kolo to a point due north of the village of Sonukofe.
- Thence it runs in a straight line due south to the village of Sonukofe.
- 14. Thence it follows the left bank of the River Volta downstream to the village of Baji Lower.
- 15. Thence crossing the River Volta in a southerly direction to the cross bush track approximately \(\frac{1}{4} \) mile due south of the village of Batawkobuakope so as to exclude Lower Baji from the district.
- 16. Thence it runs in a straight line in a south-westerly direction to the town of Dedukope.
- 17. Thence it runs in a straight line in a southerly direction, so as to include the town of Dedukope in the district, to a point approximately 2 miles north-east of the village of Dawa and 1 mile north-north-east of Survey Beacon No. C.F.P. 164.
- 18. Thence it runs in a straight line in a westerly direction to a point midway between the villages of Some Wayo and Some.
- Thence it runs in a straight line in a north-westerly direction to Survey Beacon marked 2015 on Muate Hill.
- 20. Thence it runs in a straight line in a westerly direction to a pillar marked A-VR 2 on the road from Akawle to Agomeda.
- 21. Thence it runs in a north-westerly direction to where the stream Aplachi crosses the road from Trom to Aseseiso at a boundary pillar marked A-VR 1.
- 22. Thence it follows the thalweg of the stream Aplachi upstream to the point where it crosses the track from Aperade to Trom.
- 23. Thence it runs in a north-easterly direction in a straight line to where the Krobo western boundary cuts the road from Aperade to Trom at a point about 1½ miles due west of Trom.
- 24. Thence it runs in a straight line in a north-westerly direction to Asuansi village, that village to be included in the district.
- 25. Thence it runs due north to a point 1 mile north of the track from Okrakwajo to Somanya.

- 26. Thence it runs parallel to and 1 mile north of the road from Okrakwajo to Somanya until it reaches a point 1 mile north of where the River Nyense crosses the road from Koforidua to Okrakwajo close to but west of Okrakwajo.
 - 27. Thence it runs due south to the above-named point where the River Nyense crosses the road from Koforidua to Okrakwajo.
 - 28. Thence it runs in a straight line in a westerly direction to a large rock approximately 700 yards west of the village of Ntronang so as to exclude the village of Ntronang from the district.
 - 29. Thence it runs in a north-westerly direction to a pillar marked G.H.P.
 - 30. Thence it runs in a north-westerly direction for an approximate distance of 3,650 yards to a point where a tree marked J.S. 1921 now stands.
 - 31. Thence in a north-westerly direction to the starting point of the district at Point No. 1.
